Project Governance




Figure 1 – Project Management organizational Hierarchy

The governance of the UNITE! Widening project is illustrated in Figure 1. It comprises two advisory boards: the Scientific Advisory Board (SAB) and the Quality Management Board (QAB). Additionally, there is the General Assembly (GA) and the Work Package Leaders (WPL) board. The composition of these boards was finalized on March 31. The methodology for appointments was discussed during the kickoff meeting and at the project meeting organized in Graz in February 2024. Appointments were collected via a Google Form and through email.

The meeting started with a round of introduction, in which a brief introduction from each board member was provided.

After that F. Montemor provided a Brief description of the SAB's objectives

The Board plays a crucial role in advising on the strategic areas to be addressed in the project, taking into consideration the framework of the widening countries and the activities to be implemented, particularly the industrial doctoral school.

SAB tasks include:

 To define the research and innovation strategic areas supporting the Implementation of the PhD Industry-Embedded Doctoral Programme in PL and PT in collaboration with the non-widening countries;



• To analyze the EU framework and identify gaps for widening countries. This analysis should result in recommendations regarding the selected research areas and should be completed this year.

Prof. Joana Mendonça, from the university of Lisbon was appointed as chair of the SAB

The project also includes a Quality Advisory Board (QAB). The coordination is under WUST and includes a representative from AAVanz, 1 representative of a non academic partner from Poland, a representative from the University of Lisbon and the Members of QAMB Unite.
